Federal Bureau of Prisons awards MTC \$121 million contract Utah company will continue operating expanded correctional facility near Lubbock, Texas

(CENTERVILLE, Utah) – The Federal Bureau of Prisons (BOP) has awarded a four-year contract valued at \$121.77 million to Management & Training Corporation (MTC) of Centerville, Utah. The new contract will have MTC continue operating the Giles W. Dalby Correctional Facility in Post, Texas – about 35 miles southeast of Lubbock.

“We are very pleased the Bureau of Prisons has awarded MTC this contract, which replaces an expiring intergovernmental agreement,” said Corrections Sr. Vice President Odie Washington. “Not only will we continue to operate the facility, but the new agreement also allows MTC to expand its inmate capacity by nearly 600 beds. I am proud of the work being done at our Dalby facility and look forward to our continued operation of the site for many years to come.”

The \$121.77 million contract will fund operation of the facility for four years. Additionally, the contract includes three, 2-year “option” periods. If these options are exercised by the BOP, MTC could continue operating the site until 2017 through the current agreement. MTC has operated the Texas facility for the Bureau of Prisons since October 1998.

Ground was broken at the Dalby site last November to expand its inmate capacity. Two major inmate housing wings are being added to the prison’s primary structure and two additional buildings are under construction as well. The \$14 million project expansion will grow the facility by 22%, from 190,000 square feet to 232,000 square feet.

The correctional facility currently houses up to 1096 criminal illegal immigrants. When the new areas are ready to occupy, the inmate capacity will rise to 1670. Expansion work is expected to be completed in June of this year.

The expanded facility will also require additional staffing. The Giles W. Dalby Correctional Facility currently employs 247 MTC staff members and contracted medical personnel. This number will grow to 316 by mid-year.
