Addiction Recovery and Therapy Programs

The Idaho CAPP Facility provides several addiction recovery and therapy treatment programs to help residents overcome serious addictive behaviors. Counselors and other professionals use cognitive behavioral therapy to help rehabilitate the men so they're successful after release. The facility also provides job fairs to introduce residents to employment opportunities in the community to give them a jumpstart on finding a job after release.



Idaho CAPP Facility has achieved nationally-recognized corrections, healthcare, and safety accreditations

Idaho CAPP Facility is accredited by the American Correctional Association—achieving over **99%** compliance for both mandatory and non-mandatory standards in its most recent audit. Other accreditations and certifications include the National Commission on Correctional Health Care (NCCHC), and the Prison Rape Elimination Act (PREA).
