Otero County Prison Facility has partnered with Dona Ana Community College and Mesalands Community College to offer residents HISET classes and a variety of other courses including HVAC training, AA in Business Administration, Human Services Social Work, or Liberal Arts, AAS in General Studies Occupational, and AS in Substance Abuse Counseling. Employment after release from prison is key to reducing recidivism.
